(Revenue \$) THE ONE FAMILY SCHOLARS PROGRAM SUPPORTS SINGLE PARENTS WHO ARE EXPERIENCING OR AT RISK OF HOMELESSNESS, EMPOWERING THEM TO GRADUATE FROM COLLEGE IN ORDER TO ACHIEVE ECONOMIC STABILITY. THE PROGRAM COMBINES ONE-ON-ONE COACHING SUPPORT WITH FLEXIBLE FINANCIAL AID, DRAMATICALLY IMPROVING COLLEGE SUCCESS RATES: ONE FAMILY SCHOLARS GRADUATE FROM COLLEGE AT A RATE OF 71%, COMPARED TO ONLY 8% FOR SINGLE MOTHERS NATIONWIDE. THIS LEADS TO LONG-TERM CAREER GROWTH, ASSET-BUILDING, AND HOUSING STABILITY, AS EVIDENCED BY THE FACT THAT 95% OF ONE FAMILY SCHOLAR ALUMNI NOW HAVE SECURE HOUSING.

THROUGH A COMBINATION OF ONE-ON-ONE COACHING AND GROUP SUPPORT, C2C HELPS PARENTS MATCH THEIR EXISTING SKILLS AND INTERESTS TO FAMILY-SUSTAINING CAREER PATHS. THE PROGRAM BEGINS WITH THREE INTENSIVE MONTHS OF COACHING, WHERE EACH PARTICIPANT DEVELOPS A DETAILED PLAN TO OBTAIN THE CREDENTIALS THEY NEED, AND TO ENTER THEIR CHOSEN CAREER. EACH PARTICIPANT THEN RECEIVES A YEAR OF FOLLOW-UP COACHING TO ENSURE THEY STAY ON TRACK TO THEIR GOALS. ON AVERAGE, NEW JOBS SECURED THROUGH C2C LEAD TO AN INCOME INCREASE OF \$22,475! THIS PROVIDES MUCH-NEEDED STABILITY IN THE SHORT-TERM, AND SETS A NEW FLOOR FOR FUTURE CAREER GROWTH.
